Objectives and Goals



The **AXIS Foundation, Inc. & Substance Abuse Medical Mgmt (SAMM)** are independent, non-profit, 501(C)(3) organizations that seek to be a leader in intervention and motivational services for at-risk youth.

Our mission is to address the causes and consequences of crime and violence through research, demonstration and advocacy, as well as providing a deterrence to criminal activity through tools that motivate staying in school and counseling specific to substance abuse and testing.

Since our founding in 2007, and establishment in 2008 the AXIS has begun to develop new concepts and programs in substance abuse testing and counseling as well as intervention and motivational services promoting equality in restorative justice within the social and criminal justice systems.

Motivation & Intervention

The intent is to create a full 'wrap-around' program that supports the dream by providing: transitional care; substance abuse counseling; financial and job skills training soft-skills and a hand that supports empowerment and encouragement.

Additionally, for a young person that has already been 'labeled', the intent is to intervene through counsel, testing and use of creative programs that provide motivation to change.

The objective of our organization is to team up with Government and County Agencies, in addition to outside independent professional organizations with credentials in order to facilitate research as well as the provision of services that serve to protect and/or diminish destructive behavior for compliance to court mandates.

Substance Control Medical Management Services can have Urine, Serum, and Hair Follides tested and analyzed with all results provided within 24-48 hours. A certified medical review officer reviews all test results, positive or negative.

Substance Control Medical Management Services has contracted with the U.S. HealthWorks and their test sites.
